

PPM - House Rules and Regulations :
Conditions of Use :PPM Multimedia equipment
PPM Point Public Multimédia (Public Multimedia Point).

General :

/The PPM is a public service provider, to the Public in conjunction and on behalf of ; The Municipal Council of BLANZAC.

/The PPM offers the general public the facilities to enable access to information using communication by computer aided technology and thus provides an initiation into the use of these new technologies.

/The PPM's opening hours are displayed on the timetable at the entrance. It is available to all subscribing members.

/ Access is restricted for the under 18's who are not accompanied by an appropriate adult, but they can access selected PPM sites. In the case of precise research requests however, the PPM supervisor would be able (with prior notification) to oblige and assist in the pertinent research on the Web.

Terms and conditions of access

Posters are displayed to provide available access times for all work stations.

The allocated user time per person is limited (this is at the discretion of the PPM Supervisor) this then allows more people, the opportunity to access the facilities.

/A maximum limit of 2 people are allowed at each work station.

/There is a charge for using the work stations(Annual subscription of a fixed charge which is agreed by the Municipal Council) except for the first discovery session which is free of charge.

Services

The PPM has numerous multi-media work stations. They allow for the following :

- ⌚ To read Emails
- ⌚ Internet access
- ⌚ Office applications
- ⌚ ... and more

/ A Multimedia Supervisor is present at sessions to assist users.

/He or she is responsible for the equipment maintenance and to supervise and ensure that the rules and regulations are upheld. The Supervisor is authorised to expel anyone who disrespects or breaks the house rules.

/The individual subscription charges are fixed by the Municipal Council. The services provided are strictly for private and personal use only.

/Use of your own personalised disc, CD or USB key is authorised on condition that they are verified virus free before use, by the PPM Supervisor personally.

/It possible to create one's own electronic mailbox on the condition that a free web site that allows this is utilised. Note : The user and only the authorised user is responsible for his or her own emails and their content.

Other related Legislation

/The PPM will not be held responsible for the quality of information found by Internet users.

/When using the Internet strict Laws must be adhered to, Regulations such as Copyright, Plagerism, human rights and racial hate crimes . We are committed to equal opportunities a it is not acceptable for for the PPM and it's members to access or use sites opposed to the public interest, or anti-French legislation, notably for example sites condoning and inciting violence, illegal practices, discrimination and immorality such as pornography. Copyright protected material or software ensures that the Author's information is not copied . (Copyright texts, photos, videos, maps or software must not be reproduced. No attempt to use these strictly private sites or information will be tolerated. Copying copyright or false usage is an offence which carries a 2 year prison sentence together with a fine of 150,000 Euros.

User Agreement

/If the user breaks any equipment, it must be replaced by him/herself. The condition of equipment is regularly checked before and after each session by the PPM Supervisor.

/ The PPM retains a list of all consulted sites throughout the day for statistical purposes and also sites consulted during sesssions ,in the event of mis-use to check that no house rules or regulations have been broken and to maintain standards.

/Any user who disrepects these rules risks immediate suspension of the work stations use and will be prosecuted by the relevant authority on behalf of the injured party or victim for the offense committed.
